When you are replacing an existing sign use the checklist entitled "Existing Sign Permit Procedures".

- 1) **Site plan to scale with dimensions and information as follows:**
  - a) Scale to be no greater than 1 inch = 20 ft
  - b) Show entire property including front, side, and rear yards
  - c) Property lines along the street (street frontage)
  - d) Street lines (face of curbs or edge of paving if no curbs)
  - e) Distance from street centerline to street line (curb or edge of paving)
  - f) Right-of-way lines (ultimate right of way)
  - g) Line-of-sight triangle lines (at intersections, see land development book figure IV-3 for guidelines)
  - h) Locate sign on plan
- 2) **Detail drawings showing:**
  - a) Elevation drawing showing actual sign with lettering and artwork
  - b) Label the colors
  - c) Dimensions of sign including frame
  - d) Dimensions of the support structure if not mounted directly on the building
  - e) Mounting details if mounted on wall
  - f) Dimensions of the actual sign area excluding any structural frame
  - g) Total height of sign from ground or (from roof surface if mounted on roof)

  - j) Plan view of sign
- 3) **Acknowledgment in writing from property owner/landlord for permission to erect each of the signs depicted.**

- 5) **Name, address, and telephone number of the sign installation company.**

**1) Attach a copy of your original sign permit and a sketch of the replacement sign.

**1) Include a site plan to scale with dimensions and information as follows:**

- a) Scale to be no greater than 1 inch = 20 ft
- b) Show entire property including front, side, and rear yards
- c) Property lines along the street (street frontage)
- d) Street lines (face of curbs or edge of paving if no curbs)
- e) Distance from street centerline to street line (curb or edge of paving)
- f) Right-of-way lines (ultimate right of way)
- g) Line-of-sight triangle lines (at intersections, see land development book figure IV-3 for guidelines)
- h) Locate sign on plan
